Approval of June 9, 2021 Wildlife Resources Commission (NCWRC) Meeting Minutes – the Commission approved the June 9, 2021 NCWRC minutes as written in the exhibit. **(Exhibit A)**

Adoption Of North Carolina Wildlife Resources Chronic Wasting Disease (CWD) Response Plan – the Commission adopted the revised North Carolina Wildlife Resources Chronic Wasting Disease (CWD) Response Plan **(Exhibit C)**.

Motion from Committee of the Whole – on a motion from the Committee of the Whole the Commission adopted a Resolution on Recovering America’s Wildlife Act (RAWA).

Phase II Land Acquisitions – the Commission approved the acquisition of the Hawkins Tract in Caldwell County **(Exhibit D-1)**, the acquisition of the Handy Tract in Alleghany County **(Exhibit D-2)**, the acquisition of the Three Top Tract in Ashe County **(Exhibit D-3)**

Other Property Matters – the Commission approved a staff request to donate the house and 1.28-acre lot a Texas Plantation Game Land to Tyrrell County to refurbish, repurpose and maintain the house and property **(Exhibit E-1)**, a Temporary Construction Easement and Permanent Utility Easement to Fayetteville Public Works Commission near Lake Rim in Cumberland County **(Exhibit E-2)**, tabled a permanent right-of-way easement request at Needmore Game Land to a private property owner until a before and after appraisal is performed and the potential easement value is brought back to the Land Acquisition and Property Committee for further discussion **(Exhibit E-3)**, and voted in favor of placing an informational kiosk located on the Sandy Mush Game Land as well as a story in Wildlife in North Carolina magazine detailing significant contributions of Mr. Forrest Jarrett and Mr. Gene Hartman in lieu of renaming the Sandy Mush Game Lands after them **(Exhibit E-4)**.

Adoption – 15A NCAC 10C – Inland Fishing Regulations – the Commission reviewed public comments and adopted rules for Game Fish, Primary Nursery Areas, and Anadromous Fish Spawning Area **(EXHIBITS I-1, I-2)**.

Adoption – 15A NCAC 10F .0329 – Rowan County – the Commission reviewed public comments and adoption of an extension of the no-wake zone at Tamarac Shores Marina on High Rock Lake **(EXHIBITS J-1, J-2)**

Adoption – 15A NCAC 10F .0317 – Stanly County – the Commission reviewed public comments and adoption of an extension of the no-wake zone within 50 yards of the railroad trestle on Badin Lake **(EXHIBITS K-1, K-2)**

Adoption – 15A NCAC 10F .0327 – Montgomery County – the Commission reviewed public comments and adoption of an extension of the no-wake zone within 50 yards of the Old North State Marina fuel dock **(EXHIBITS L-1, L-2)**

Election of Officers – the Wildlife Resources Commission elected Commissioner Monty Crump as Chairman and Commissioner Tommy Fonville as Vice Chairman for a term of two years or until their successors are elected and qualified pursuant to NCGS §143-243.
