INSTRUCTIONS FOR COMPLETION OF REPORT

1. Please print or type this form.
2. **Name, address and license number** - Pertaining to individual listed on the license.
3. **Collection Location** - List only **one** collection site on each line (A.-F.). List county and exact location referenced by distance to nearest road, town, bridge, etc.
4. **Common Name** - List the most commonly recognized name of the wildlife species.
5. **Scientific Name** - List the currently accepted scientific name of the wildlife species.
6. **County** - List the county where the wildlife species was collected.
7. **Lat-Long** - List the latitude and longitude of the collection site from NC Department of Transportation Maps.
8. **Loc.** - List the alphabetic letter which denotes the above listing of the collection location.
9. **Date** - List the date of the collection.
10. **No.** - List the number of specimens collected.
11. **Disposition** - List the disposition of the specimens collected [released alive, university/museum collection, tagged and released (specify tag number and type), etc.].
12. **Comments** - As specified.
13. **License renewal** - Licenses will **not** be renewed unless requested. **Annual renewal fee of \$5.00 + a \$2.00 transaction fee are required for each license** (Fee is waived for government agencies and public institutions.)
14. **Certification** - Signature is required for report acceptance and license renewal.
