**Phase II Land Acquisitions** – the Commission approved proceeding with the acquisition of two properties – Cunningham Tract – Swain County; Melton Tract – McDowell County. **Exhibits D-1, D-2**

**Adoption of Fiscal Note Review for Rulemaking for Yeopim Creek, Perquimans County** - the Commission adopted the Fiscal Note review of the projected cost to Perquimans County of markers at a no-wake zone on Yeopim Creek. **Exhibit E-1**

**Permanent Rulemaking – Yeopim Creek, Perquimans County** -- the Commission approved proceeding with permanent rulemaking to publish Notice of Text in the *NC Register* and hold one public hearing for an amendment to 15A NCAC 10F .0355, to establish a no-wake zone shore to shore in a portion of Yeopim Creek at Heritage Shores Subdivision in Perquimans County. **Exhibit E-2**

**Adoption of Fiscal Note Review for Rulemaking for Shooting Creek on Lake Chatuge, Clay County** - the Commission adopted the Fiscal Note review of the projected cost to Clay County to extend the no-wake zone on Shooting Creek on Lake Chatuge. **Exhibit F-1**

**Permanent Rulemaking – Shooting Creek on Lake Chatuge, Clay County** -- the Commission approved proceeding with permanent rulemaking to publish Notice of Text in the *NC Register* and hold one public hearing for an amendment to 15A NCAC 10F .0308, to extend the no-wake zone shore to shore in Shooting Creek on Lake Chatuge in Clay County. **Exhibit F-2**

**Permanent Rulemaking – Lake James, Burke County** – the Commission adopted a request by Burke County to publish Notice of Text in the *NC Register* and hold one public hearing to promulgate rulemaking under 15A NCAC 10F .0323, for a no-wake zone in Sherman’s Hollow Cove and within 50 yards of the shoreline of Linville Point on Lake James. **Exhibit G**

**Adoption of Fiscal Note Review for Rulemaking for the Town of Surf City, Pender County** - the Commission adopted the Fiscal Note review of the projected cost to the Town of Surf City to place markers for a no-wake in the channel known as Deep Creek along the Surf City waterfront. **Exhibit H-1**

**Permanent Rulemaking –Town of Surf City, Pender County** -- the Commission approved proceeding with permanent rulemaking to publish Notice of Text in the *NC Register* and hold one public hearing for an amendment to 15A NCAC 10F .0321, to establish a no-wake zone in the channel known as Deep Creek along the Surf City town waterfront in Pender County. **Exhibit H-2**
