SWEARING IN OF COMIMISSION APPOINTEES THOMAS A. BERRY, MARK R. CRAIG, JAMES W. COGDELL, HAYDEN ROGERS, AND JOHN T. COLEY IV

Chairman Hoyle introduced North Carolina Secretary of State Elaine F. Marshall and thanked her for agreeing to administer the Oath of Office to five newly appointed Commissioners. Secretary Marshall administered the Oath of Office to Thomas A. Berry, Commissioner at Large appointed by President Pro Tempore Phil Berger; to Mark R. Craig, Commissioner at Large appointed by the President Pro Tempore; Hayden Rogers, District 9 Commissioner appointed by Governor Bev Perdue; James W. Cogdell, District 6 Commissioner appointed by Governor Perdue; and John T. Coley IV, Commissioner at Large appointed by House Speaker Thom Tillis. Each Commissioner was given a Holy Bible used for his Oath of Office. Chairman Hoyle presented Secretary Marshall with a 2011 Wildlife calendar with appreciation for her assistance and friendship to the Commission.

## PRESENTATION OF 2011 THOMAS L. QUAY AWARD

Executive Director Gordon Myers introduced Richard B. Hamilton, the 2011 winner of the Thomas L. Quay Wildlife Diversity Award, noting his contributions to wildlife diversity in his 37-year career with the N.C. Wildlife Resources Commission. Among his many accomplishments Hamilton oversaw establishment of the Non-Game Wildlife Advisory Committee in 1986, and served as Executive Director of the agency from 2004-2007. Director Gordon Myers read a resolution in Hamilton's honor, unanimously adopted and incorporated by reference into the official record of this meeting, and presented him with a plaque and framed wildlife print.

## NON-GAME WILDLIFE ADVISORY COMMITTEE SPECIAL PRESENTATION

Executive Director Myers recognized Dr. David Webster, a member of the Non-Game Wildlife Advisory Committee, for Webster's ongoing efforts in coordinating the actions of the six Scientific Councils that work with endangered, threatened and special concern species and make recommendations to the Wildlife Resources Commission. Myers presented Dr. Webster with a certificate of appreciation and a framed print.

The Commission meeting recessed at 9:30 for 15 minutes so that photographs could be taken.

## ADMINISTRATION

Tommy Clark, Budget Officer, gave a Financial Status Report as of June 30, 2011, presented in Exhibit C. The Operating Fund balance is $\$ 20,845,004.99$. The Endowment Fund balance is $\$ 82,817,579.19$. Clark then presented a financial status report on the annual interest allocation for the Endowment Fund as of June 30, 2011, presented in Exhibit D. On a motion by Joe Barker and second by Nat Harris the Commission approved the allocation of $\$ 3,609,567.14$ to the Sportsmen Funds. The Commission approved $\$ 183,561.65$ to be allocated to the Magazine Fund, which represents 100 percent of the interest derived from sales of lifetime magazine subscriptions. ## WILDLIFE MANAGEMENT SPOTLIGHT

Reptile and Amphibian Projects in the Piedmont and Coastal Plain - Dr. Jeff Humphries, Wildlife Diversity Biologist, presented an update on the some of the projects funded by the State Wildlife Grants, working with identifying priority species and strategies for conservation among amphibians and reptiles in the Piedmont and Coastal Plain. Dr. Humphries highlighted efforts to restore the habitats of the Carolina gopher frog which is a threatened amphibian species in North Carolina. The Carolina gopher frog is an indicator of a healthy ecosystem in the lowland pine forest but only seven populations of the Carolina gopher frog remain. The Carolina gopher frog is pictured on the 2011 State Fair button distributed by the NCWRC.

## WILDLIFE MANAGEMENT UPDATE

Dr. David Cobb, Wildlife Management Division Chief, provided an update about the activities of the Division of Wildlife Management. He provided CDs with information about rule proposals for statewide public hearings, a document about species and habitat recommendations, and copies of publications of interest to the Commissioners.

## PROPERTY ACQUISITION- CAMDEN COUNTY

Upon a motion by Durwood Laughinghouse and second by Nat Harris the Commission approved staff recommendation presented in Exhibit E by Dr. David Cobb, to work with the State Property Office for the acquisition by donation from North River Associates of the North River Associates-Sedel Tract in Camden County, as an addition to the North River Game Land. Exhibit E is hereby incorporated into the official record of this meeting.

## REQUEST TO INSTALL MONITORING WELLS - GAME LANDS IN PENDER COUNTY

Dr. Cobb presented Exhibit F, a request by Southern Environmental Group, Inc. on behalf of Shelter Creek Capital, LLC to work with the State Property Office to provide a temporary easement to Southern Environmental Group, Inc. to install and monitor hydrological wells on Angola Bay and Holly Shelter Game Lands in Pender County. The wells are a requirement of the Division of Water Quality's permit that regulates the discharge of stormwater, mine dewatering, and wastewater under the National Pollution Discharge Elimination System. A motion to adopt the request for temporary easement was made by Joe Barker, seconded by Jim Cogdell, and carried. Exhibit F is hereby incorporated into the official record of this meeting.

## PROPERTY DISPOSAL REQUEST - CHOWAN SWAMP GAME LAND, GATES COUNTY

Dr. Cobb presented a staff recommendation in Exhibit $\mathbf{G}$ to dispose of three structures constructed by a hunt club in Gates County circa 1950, on what now is part of the Chowan Swamp Game Land. The Gates County Emergency Management Service has expressed interest in burning the structures as a fire department exercise. Berkley Skinner made a motion to adopt the request for disposal with a second by Nat Harris. During discussion Dell Murphy asked about possibly leasing one or more of these structures for youth activities on the Game Land. With that possibility in mind, Durwood Laughinghouse made a motion to table discussion until staff investigates and reports back to the Commission. That motion was seconded by Hayden Rogers and carried. Exhibit G is hereby incorporated into the official record of this meeting.

## 2011-2012 WATERFOWL SEASONS

The Commission received a summary concerning trends in duck breeding populations, 1955-2011, from Dr. David Cobb in Exhibit I-1.
Exhibit I-2 is a review of U.S. Fish and Wildlife Service frameworks for 2011-2012 late hunting seasons for certain migratory game birds.
Exhibit I-3 is a summary of comments received online about 2011-2012 waterfowl seasons.
On a motion by Doug Berkley Skinner and second by Joe Barker, the Commission adopted bag limits, shooting hours, and season dates for waterfowl seasons occurring after September 30, presented in Exhibit I-4:

Note: Possession limits are twice the daily bag for all seasons unless otherwise noted.
Hours: One-half hour before sunrise to sunset.

Youth Waterfowl Days: December 10, 2011 and February 4, 2012 (youth must be age 15 or younger and accompanied by a properly licensed adult. The adult cannot duck hunt but may participate in other seasons that are open on the special youth day.)
Species include ducks, geese, brant, mergansers, coots and tundra swans. The youth must have a valid permit to harvest a Canada goose (NE Hunt Zone only) or a tundra swan.

The season on harlequin ducks is closed. (Possession limits are twice the daily bag unless otherwise noted.)

- 5 mergansers (2 hooded mergansers)

- 5 dark geese (includes Canada geese and White-fronted geese) in the Resident Hunt Zone, 5 in the Southern James Bay Zone and 1 in the Northeast Hunt Zone.

Falconers may also hunt during the applicable gun seasons. Daily bag and possession limits of 3 and 6 , respectively, apply while hunting during the gun season.

With the following exception, falconry hours for all species are from $1 / 2$ hour before sunrise until sunset. For doves on September 3 (gun season), falconry hours are from noon until sunset.

Falconry is not allowed on Sunday.
Daily bag and possession limits are for all species singly or in the aggregate. For example, if the applicable season(s) are open, a daily bag may consist of 3 doves or 1 dove, 1 duck and 1 woodcock for a total of 3 migratory game birds.

## ADOPTION OF A SEASON TO ALLOW THE TAKE OF MIGRANT PEREGRINE FALCONS

On a motion by Dell Murphy and second by Joe Barker the Commission adopted the proposal presented in Exhibit J to establish a 2011 season for the take of one live migrant juvenile peregrine falcon for use in falconry, with the following stipulations:

- Total allowable take is 1 bird during the period from September 20, 2011 through October 20, 2011.
- All birds taken must be juveniles.
- Take would be allowed only by permit from the WRC and only east of US Highway 17.
- No banded birds may be taken. Any banded birds captured must be immediately released at the site of capture.
- Permits will be issued through our special hunts permitting system (random).
- One permit will be issued to N.C. residents only.
- An individual issued a permit must have the proper state and federal falconry licenses/permits.
- Each person receiving a permit must complete a post-season survey provided by DWM staff and submit that survey no later than December 15, 2011.
Note: The state of New Jersey has been allocated one peregrine falcon for take during 2011 but action will not have been taken until September 22, 2011. If for any reason those rules are not adopted by N.J., the one peregrine allocated by the FWS in N.J. will be available for take in N.C. If rules are not adopted to allow peregrine take in N.J. the WRC will accept the re-allocation of one peregrine and will issue a second permit for take of peregrine in N.C. There will be no residency restriction on the second permit.

## RECEIVE PUBLIC COMMENTS REGARDING TEMPORARY RULEMAKING AND ADOPTION OF TEMPORARY RULES

Dr. Cobb presented Exhibit K-1, a summary of public comments pertaining to proposed temporary rulemaking for the take of crows and coyotes by electronic call and for the creation of an open season with no bag limit for the take of feral swine.

Dr. Cobb presented Exhibit K-2, the staff recommendation to adopt temporary rules under 15A NCAC 10B. 0215 for the take of crows with electronic calls and under 15A NCAC 10B . 0219 for the take of coyotes with the use of electronic calls; and for an open season with no bag limits for the take of feral swine under 15A NCAC 10B .0223. The motion to adopt temporary rules was made by Wes Seegars, seconded by Nat Harris, and carried. Test kits will be available from the Department of Agriculture for testing feral swine. Brucellosis may be carried by feral swine and is transmissible to humans. Exhibits K-1 and K-2 are hereby incorporated into the official record of this meeting.

## INLAND FISHERIES UPDATE

The Commission received an update about the activities of the Inland Fisheries Division from Bob Curry, Inland Fisheries Division Chief. He announced that the Mountain State Fair will be held September $9-18$. National Hunting and Fishing Day is September 24. There will be state-wide family oriented events. Twenty-six project proposals have been received for consideration using Coastal Recreational Fishing License (CRFL) funds. Curry announced that the Wildlife Action Plan is being updated. He announced the Lake Norman fish kill and a fish kill at Jordan Lake.

## PROPERTY ACQUISITION - WARREN COUNTY

Bob Curry presented Exhibit L, the staff recommendation to acquire property adjacent to Shocco Creek Game Lands northeast of Centerville in Warren County for inclusion into the Game Lands or Wildlife Conservation Area programs, to seek appropriate funding and forward to the State Property Office. Joe Barker made a motion to approve with a second by Dell Murphy. The motion carried. EXHIBIT L is hereby incorporated into the official record of this meeting.

## FISCAL NOTE FOR RULEMAKING UNDER 15A NCAC 10F .0313-HYDE COUNTY

Norman Young, Rulemaking Coordinator presented an explanation of the requirement under the Regulatory Reform Act that a fiscal note showing any impact on state or local government first be approved by the WRC as part of the Notice of Text, which is published for at least 60 days before the Commission may consider the rule for adoption. A proposed no wake zone in Lake Landing Canal in Hyde County will be considered by the WRC after the required notice and comment period end. Norman Young presented in Exhibit M the fiscal note analysis required for the rule proposal. A motion to adopt the fiscal note was made by Berkley Skinner, seconded by Joe Barker and carried. Exhibit $\mathbf{M}$ is hereby incorporated into the official record of this meeting.

## ELECTION OF VICE CHAIRMAN

Pursuant to NCGS 143-243, the requirement that the Wildlife Resources Commission shall elect a Vice-Chairman to serve for a two-year term, Mitch St. Clair made a motion to elect Ray White as Vice Chairman. That motion was seconded by Berkley Skinner. Steve Windham then made a motion to close the nominations, with a second by Joe Barker. The Commission unanimously elected Ray White as Vice Chairman.

## COMMITTEE REPORTS

Joint Big Game / Habitat, Non-Game and Endangered Species Committee Report - John Litton Clark, Big Game Committee Chairman, reported that the committees met on August 24, 2011. Discussion included elk, alligator and bear management issues. Clark stated that the General Assembly may consider a bill for hunting alligators. The WRC will be proactive and conduct density studies. Clark stated that the National Park Service will defer management of the elk off park property to the Wildlife Resources Commission. The WRC is preparing a management plan for elk that leave the National Park. Discussion also included information received at the listening sessions held across the state regarding bear management issues.

Fisheries Committee Report - Wes Seegars, Fisheries Committee Chairman, reported that 29 people attended the Fisheries Committee meeting on August 24. Chad Thomas made a presentation on anadromous fish status including American shad and river herring. Seegars reported that the Coastal Recreational Fishing License (CRFL) report was explained to the new Commissioners.
Motion: The Commission adopted a motion from the Fisheries Committee made by Dalton Ruffin and seconded by Berkley Skinner to approve the draft North Carolina Estuarine Striped Bass Management Plan, a joint effort between the Wildlife Resources Commission and Division of Marine Fisheries. Motion: Ray White made a motion from the Fisheries Committee, seconded by Steve Windham, to move the CHPP (Coastal Habitat Protection Plan) implementation plan forward. The motion carried.

Education and Outreach Committee Report - Dell Murphy, Education and Outreach Committee Chairman, reported that Bob Curry gave a report about the Education Centers at the August 24 committee meeting. Erik Christofferson talked about the recent changes in the Wildlife in North Carolina magazine.

Committee of the Whole Meeting Report - Chairman David Hoyle, Jr, reported that staff gave a great orientation to the new Commissioners on August 23. He reported that more than 300 people attended the bear listening session in Waynesville. At the bear listening session coon hunters stated that they want to be able to feed raccoons in areas of the State that have an open season for taking black bears. NCGS 113-294 was amended by Session Law 2007 - 96, which prohibits the placement of "processed food products" as bait in areas that have set an open season for taking black bears, including dog food used to supplement naturally available foods for raccoons. Executive Director Gordon Myers read a resolution that would allow placement of dry dog food to attract or feed raccoons in areas that have set an open season for taking black bears, provided that the dry food is placed in a single closed container no larger than five gallons, that the product is accessible only through a tube requiring that the raccoon reach into the closed container, and that each container is secured to a tree or post on the ground or in an elevated position to reduce the attractiveness to bears. This policy constitutes the agency interpretation of NCGS 113-294 for enforcement purposes and not rulemaking.
Motion: Dalton Ruffin made a motion to adopt the resolution. The motion was seconded by Berkley Skinner. The Commission adopted the resolution, which is hereby incorporated into the official record of this meeting.

## COMMENTS BY THE EXECUTIVE DIRECTOR

Executive Director Gordon Myers thanked the new Commissioners for coming to Raleigh early for the orientation. He announced that state-wide public hearings start the Tuesday after Labor Day and invited the Commissioners to attend. The agency also has scheduled seven Town Hall meetings with employees across the state.

## COMMENTS BY THE CHAIRMAN

Chairman David Hoyle, Jr. reminded Commissioners that photographs would be taken on the first floor immediately following the meeting. He presented Steve Windham with a framed print in appreciation for his service as Chairman.

The next meeting of the Wildlife Resources Commission will be held Wednesday, November 10 , 2011.

## ADJOURNMENT

There being no further business the meeting was adjourned by Chairman Hoyle at 11:50 a.m.

## Resolution Regarding Supplemental Feeding of Raccoons

Whereas, N.C.G.S. § 113-294 was amended by SL 2007-96 to prohibit the placement of "processed food products" as bait in any area of the State where the Wildlife Resources Commission has set an open season for taking black bears; and

Whereas, this amendment did not limit such bait to that placed to attract black bears only, but applies to any bait placed for any animal if that bait falls under the definition of "processed food products"; and

Whereas, this law defines "processed food products" as:
".. any food substance or flavoring that has been modified from its raw components by the addition of ingredients or by treatment to modify its chemical composition or form or to enhance its aroma or taste. The term includes substances modified by sugar, honey, syrups, oils, salts, spices, peanut butter, grease, meat, bones, or blood, as well as extracts of such substances. The term also includes sugary products such as candies, pastries, gums, and sugar blocks, as well as extracts of such products." and;

Whereas, a number of hunters routinely supplement naturally available foods for raccoons with commercially available dog food products; and

Whereas, the use of commercially available dog food products was not specifically addressed within the definition of "processed food products" in N.C.G.S. § 113-294; and

Whereas, this legislation has created uncertainties with respect to users of commercially available dog food products for supplemental feeding of raccoons in areas where the Wildlife Resources Commission has set an open season for the taking of black bears.

Now, therefore, be it resolved, that the North Carolina Wildlife Resources Commission sets forth the following policy regarding the use of commercially available dog food products for supplemental feeding of raccoons pursuant to N.C.G.S. § 113-294 as amended:

1) Any commercially available dog food product, whether placed with unprocessed food products or by itself, shall be deemed by this Commission to be a processed food product within the meaning of N.C.G.S. § 113-294. However, the placement of commercially available dog food products specifically for the purpose of attracting or feeding raccoons shall not be considered illegal under N.C.G.S. § 113-294, provided:
(a) that such placement is within a single closed container no larger than five gallons,
(b) the dog food product is accessible only through a tube requiring that the raccoon reach into the closed container, and
(c) each container is secured to a tree or post, either on the ground or in an elevated position, so as to reduce attractiveness to bears.
2) The prohibition against taking bears with the use or aid of bait shall apply to the release of dogs in the vicinity of any commercially available dog food product whether placed for the purpose of attracting or feeding raccoons or otherwise.
3) This policy constitutes the agency interpretation of N.C.G.S. § 113-294 for enforcement purposes rather than rulemaking. It shall remain in effect until such time as it is altered by this Commission or by an action of the General Assembly.

Resources Assessment: This tract is adjacent to and contiguous with land owned by Military Ocean Terminal at Sunny Point (MOTSU), and also adjacent to approximately 400 forested acres owned by Brunswick County and 400 forested acres owned by the Clean Water Management Trust Fund. Together these tracts comprise a landscape scale initiative aimed at the conservation of upland Longleaf Pine in an area of exceptional biological diversity. Though the Swain Tract is incompletely surveyed, the immediately adjacent MOTSU is known or suspected habitat for 90 species of amphibians and reptiles, 44 of which are state listed and/or SWAP priority species. Additionally, MOTSU harbors a population of the federally endangered Red-Cockaded Woodpecker (RCW). Of particular significance, the Swain Tract contains upland Longleaf Pine forest and 5 isolated wetlands. These habitats are likely used by the State Threatened Carolina Gopher Frog, a species now known to occur at only 7 locations statewide. Gopher frog tadpoles were recently located in a pond on MOTSU within 50 yards of the Swain tract. Large Longleaf Pines occur throughout the property, but they are interspersed with Loblolly Pine and hardwood species because of lack of prescribed fire over several decades. Acquiring this property would enhance the sustainability of Gopher Frogs and RCWs, as well as numerous other species of wildlife.

## PROPOSED CHANGES IN FERAL SWINE REGULATIONS RECOMMENDED BY AGENCY STAFF FOR TEMPORARY RULE-MAKING

Add feral swine to the Commission's trapping rules with no closed season and no bag limit with the following restrictions:

- Swine trappers must have a Commission-issued permit in addition to a hunting or trapping license.
- Feral swine may be live-trapped using only corral or box traps.
- Corral and box traps must be constructed in a manner such that a non-target animal can be easily released or can escape without harm.
- Permit numbers must be placed on all traps.
- Feral swine must be euthanized while in the trap and may not be removed alive from any trap.


## Explanation:

Under current rules feral swine may only be trapped under a depredation permit, which requires an economic justification, threat to human safety or documented overabundance. These temporary rules, to be followed by permanent rules at a later date, will allow greater flexibility for the take of feral swine.

Proposed rule text for temporary rules:

15A NCAC 10B . 0303 OPEN SEASONS
(a) General. Following are the seasons for taking by trapping fur-bearing animals as defined in G.S. 113-129(7a), coyotes, armadillos, and groundhogs, all dates being inclusive:
(1) November 1 through the last day of February except for that part of the state described in Subparagraph (2) of this Paragraph.
(2) December 1 through the last day of February in and east of Hertford, Bertie, Martin, Pitt, Greene, Lenoir, Duplin, Pender and New Hanover counties.
(3) Trapping coyotes is allowed during times and with methods described by local laws in counties where local laws have established fox trapping seasons even when those seasons fall outside the regular trapping seasons described above.
(4) Nutria may be trapped east of I-77 at any time.
(b) Feral Swine. There is no closed season for trapping feral swine subject to the following restrictions:
(1) In addition to a hunting or trapping license, a permit issued by Wildlife Resources Commission staff is required to trap feral swine.
(2) Feral swine may be live-trapped using only corral or box traps. Corral and box traps must be constructed in a manner such that a non-target animal can be easily released or can escape without harm. The permit number must be displayed on all traps.
(3) Feral swine must be euthanized while in the trap and may not be removed alive from any trap.

## NO WAKE ZONE REQUEST - HYDE COUNTY, LAKE LANDING CANAL 15A NCAC 10F . 0313

The Board of Commissioners of Hyde County held a public hearing and submitted a certified Resolution and application for an amendment to 15A NCAC 10F .0313, to establish a no wake zone within the waters of a portion of Lake Landing Canal.

Staff investigated the area and noted that the shallow and narrow canal presents hazards to water safety particularly in the portion of the canal beginning near the SR 1110 bridge, to a point southeast around a series of curves in the vicinity of the Last Chance community.(See map)

Hyde County has agreed to bear the cost of the purchase, placement and maintenance of the no wake markers. An analysis of minor fiscal impact to local government was adopted by the Wildlife Resources Commission and submitted and certified by the Office of State Budget and Management.

Notice of Text was published in the North Carolina Register pursuant to the Administrative Procedure Act. A public hearing to receive comments on the request was held in Raleigh on August 31, 2011. There were no comments received and no attendees at the public hearing.

Staff recommends adoption of the amendment:

## 15A NCAC 10F . 0313 HYDE COUNTY

(a) Regulated Areas. This Rule applies to the following waters in Hyde County:
(8) The waters of Lake Landing Canal beginning near the SR 1110 bridge at the intersection of Great Ditch Road and Nebraska Road, at $35,45926 \mathrm{~N}, 76.07527 \mathrm{~W}$ and ending at $35,45027 \mathrm{~N}, 76,06862$ W;
(b) Speed Limit. No person shall operate a motorboat or vessel at greater than no-wake speed on the regulated areas described in Paragraph (a) of this Rule.
(c) Placement and Maintenance of Markers. The Board of Commissioners of Hyde County is designated a suitable agency for placement and maintenance of the markers implementing this Rule, subject to the approval of the United States Coast Guard and the United States Army Corps of Engineers.

## NO WAKE ZONE REQUEST - HYDE COUNTY, MATTAMUSKEET LAKE CANALS 15A NCAC 10F . 0313

On behalf of the U.S. Fish and Wildlife Service, the Board of Commissioners of Hyde County held a public hearing and submitted a certified Resolution and application for an amendment to 15A NCAC 10F .0313, to establish no wake zones within the waters of portions of the Central Canal, East Main Canal, and West Main Canal immediately adjacent to the Mattamuskeet Lodge on Mattamuskeet Lake.

Staff investigated the area and noted that placement of no wake zones within the area will mitigate hazards to water safety and potential for accidents and violations in the area close to the lodge.

The U.S. Fish and Wildlife Service has agreed to bear the cost of the purchase, placement and maintenance of the no wake markers at no expense to local or state government. Therefore no fiscal note is required pursuant to NCGS 150B-21.4.

Notice of Text was published in the North Carolina Register pursuant to the Administrative Procedure Act. A public hearing to receive comments on the request was held in Raleigh on August 31, 2011. There were no comments received and no attendees at the public hearing.

(9) A portion of Main Canal off of Mattamuskeet Lake in the vicinity of Mattamuskeet Lodge, beginning in East Main Canal at 35.45226, -76,17359 and extending to a point in West Main Canal at 35.45174, -76.18132, and that portion of Central Canal beginning at its intersection with Main Canal and extending northward to 35.45687. -76.1751.
(b) Speed Limit. No person shall operate a motorboat or vessel at greater than no-wake speed on the regulated areas described in Paragraph (a) of this Rule.
(c) Placement and Maintenance of Markers. The Board of Commissioners of Hyde County is designated a suitable agency for placement and maintenance of the markers implementing this Rule, subject to the approval of the United States Coast Guard and the United States Army Corps of Engineers.

## NO WAKE ZONE REQUEST - CARTERET COUNTY, FISHING CREEK 15A NCAC 10F . 0330

At the request of the U.S. Coast Guard Sector North Carolina, the Board of Commissioners of Carteret County advertised and held a public hearing on November 15, 2010 to receive public comment on a proposed no wake zone within the waters of Fishing Creek on the property of Fort Macon State Park. At the public hearing Capt. Anthony Popiel, Commander of USCG Sector North Carolina, spoke in favor of the no wake zone to mitigate hazards to water safety caused by boaters using the creek at high speeds at high tide only as a short cut, avoiding the no wake zones within the Port of Morehead City (map attached to this exhibit.) Popiel said that the very shallow and winding creek is used by canoeists and kayakers as well. Capt. Popiel indicated that Fishing Creek is not marked with Federal Aids to Navigation by the USCG because it is not deep enough for most boats to transit. At the Carteret County public hearing John Hopkins spoke against the proposed no wake zone because he uses the creek as a time and fuel saving option as he heads out of Beaufort Inlet. (excerpt from the 11-15-2010 Carteret County Public Hearing attached.)

Because Fishing Creek is on the property of Fort Macon State Park and not part of the Carteret County tax base, Carteret County deferred to the North Carolina Division of Parks and Recreation to submit the application to the WRC. The Wildlife Resources Commission received an application with certified resolution signed by Donald G. Reuter, Assistant Director of N.C. Division of Parks and Recreation. The U.S. Coast Guard has agreed to be responsible for purchase and placement of signage, at no expense to state and local government; therefore a fiscal note analysis was not required.

Staff investigated the area and recommended proceeding with rulemaking in the interest of boating safety. It was noted that the creek is navigable only at high tide and only on plane, creating hazards for motor vessel operators and a hazard for canoeists and kayakers who also use the area and may not be seen around the winding curves along most of the creek. Enforcement noted that boaters have used the cut through to avoid detection by officers looking for BWI suspects within the no wake area in the Port of Morehead City.

Notice of Text was published in the North Carolina Register pursuant to the Administrative Procedure Act. A public hearing to receive comments on the request was held in Raleigh on August 31, 2011. There were no attendees at the public hearing. However, four emails were received during the comment period in opposition to the proposed no wake zone at Fishing Creek. Emails are attached to this exhibit.

## 15A NCAC 10F . 0330 CARTERET COUNTY

(a) Regulated Areas. This Rule applies to the following waters in Carteret County:
(1) the waters of Money Island Slough beginning at the east end of Money Island near the Anchorage Marina Basin and ending at the west end of Money Island where Brooks Avenue dead-ends at the slough;
(2) the waters of Taylor Creek located within the territorial limits of the Town of Beaufort;
(3) the waters of Pelletier Creek beginning at the entrance to Pelletier Creek at the Intracoastal Waterway and ending at U.S. Highway 70;
(4) the waters of Bogue Sound in Morehead City between Sugar Loaf Island and the seawall on the south side of Evans, Shepard and Shackleford Streets and bounded on the east by the State Ports Authority and on the west by the eastern right-of-way margin of South 13th Street extended;
(5) the waters of Gallant's Channel from the U.S. 70 crossing over the Grayden Paul bridge to Taylor's Creek;
(6) the waters of Cedar Island Bay and Harbor from U.S. 70 to Cedar Island Bay Channel Light 8;
(7) the waters of the small cove on the west side of Radio Island immediately south of the $B \& M$ Railroad and U.S. 70 Bridges across the Intracoastal Waterway in which Radio Island Marina and Morehead Sports Marina are located as delineated by appropriate markers;
(8) the waters of the Newport River beginning at the north side of the Beaufort Drawbridge and ending at marker \#6;
(9) the waters of Spooners Creek within the territorial limits of the Town of Morehead City as delineated by appropriate markers;
(10) the waters of Taylor's Creek from the eastern end of the current no wake zone eastward to Channel Marker \#1A;
(11) the waters of the Newport River at Bogue Sound including all waters surrounding the Port of Morehead City to Brandt Island as delineated by appropriate markers; (12) the waters of Morgans Creek as delineated by appropriate markers;
(13) the waters of Cannonsgate Marina and the Cannonsgate Marina Channel, beginning at its intersection with Bogue Sound at $34.70163 \mathrm{~N}, 76.98157 \mathrm{~W}$ as delineated by appropriate markers; and
(14) the entire waters of Fishing Creek in the vicinity of Fort Macon State Park and U.S.C.G. Station Fort Macon, beginning at its western entrance at Tar Landing Bay and ending ai the eastern entrance near Beaufort Inlet, as delineated by uppropriate markers.
(b) Speed Limit. It is unlawful to operate a motorboat or vessel at a speed greater than no-wake speed while on the waters of the regulated areas designated in Paragraph (a) of this Rule.
(c) Placement and Maintenance of Markers. The Board of Commissioners of Carteret County, with respect to the regulated areas designated in Subparagraphs (1), (3), (5), (6), (7), (8), (10), (12) and (13) of Paragraph (a) of this Rule, and the Board of Commissioners of the Town of Beaufort, with respect to the regulated area designated in Subparagraph (2) of Paragraph (a) of this Rule, and the Board of Commissioners of Morehead City, with respect to Subparagraph (4) and (9) of Paragraph (a) of this Rule, and the North Carolina State Ports Authority, with respect to the regulated area designated in Subparagraph (11) of Paragraph (a) of this Rule, and the United States Coast Guard and the North Carolina Division of Parks and Recreation, with respect to the regulated area designated in Subparagraph (14) of Paragraph (a) of this Rule are designated as suitable agencies for placement and maintenance of the markers implementing this Rule, subject to the upproval of the United States Coast Guard and the United States Army Corps of Engineers.

Capt．Anthony Popiel，Commander of the Coast Guard Sector NC，said in dealing with boaters，they try to identify things they can do to make the waters safer and prevent accidents before they occur．He said an area that had come to their attention for a potential accident was Fishing Creek，located along the property of Fort Macon State Park from the main channel back into Bogue Sound．Capt．Popiel indicated that many boaters use Fishing Creek because there is a no wake zone along the main channel that passes downtown Morehead City through to the port area．He said when the tide was high many boaters would use Fishing Creek as a shortcut to get into Bogue Sound．Capt．Popiel said it was a narrow waterway with lots of turns that some people use for fishing，as well as canoeing and kayaking，so a boat traveling at a high rate of speed could experience difficulty maneuvering out of the way if they came upon a canoe，a kayak or a small boat．Capt．Popiel said the Coast Guard recommended the establishment of a no wake zone in this area in order to reduce the opportunity for an accident in that waterway．

Chairman Harris asked＇if there had been any accidents in the creek．Capt．Popiel said he wasn＇t aware of any but he had only been in this area since the beginning of the year so his personal knowledge of the history of the waterway was only from what he had heard from local boaters．

Motion-Commissioner Lewis moved to open the public hearing. Commissioner Robinson seconded. Motion carried unanimously.

John Hopkins from Atlantic Beach said he used this waterway multiple times a week. He said he had two slips at Triple S Marina and cutting through Fishing Creek saved him a lot of time and a lot of fuel. Mr. Hopkins said a no wake zone in this area would be a grave injustice and a tremendous inconvenience for all the people who use this waterway. He pointed out that if it was below mid-tide, Fishing Creek was too shallow to go through but if a boat was planed out, it could go through at mid-tide and above. Mr. Hopkins said $95 \%$ of the time he went through Fishing Creek he didn't see any boats, canoes or kayaks. He added that the marsh grass at mid tide might be $11 / 2$ to 2 feet above the level of the water so when someone was in a boat, they were 4 or 5 feet up so they could see from one side of the marsh to the other; therefore, he didn't see any danger of boaters not seeing one another.

Motion-Commissioner Lewis moved to close the public hearing. Commissioner Hunt seconded. Motion carried unanimously.

Chairman Harris asked Capt. Popiel if this area was classified as navigable waters. Capt. Popiel said anything that you could navigate through and get to the ocean was considered a navigable waterway. Chairman Harris asked if it was listed on any chart as a channel. Capt. Popiel sald it showed up on the charts and he referred to the information in the Board's agenda packet. He said it was a waterway that the Coast Guard doesn't mark with Federal aids basically due to the depth of the water. Capt. Popiel said it wasn't a mean low water and it wasn't deep enough to transit so they didn't mark it. Chairman Harris asked if the Wiidlife Resources Commission had any regulations on where no wake zones could be placed. Capt. Popiel said, based on their discussions with the Wildlife Commission, it basically came down to the jurisdiction that was over that geographical region. Chairman Harris said he was asking all these questions because he was concerned that the whole area was like a big marsh and establishing a no wake zone in this creek would be setting a precedent. Chairman Harris said there was also a matter of cost. He said County staff had informed him that the County doesn't own a boat that could go into this creek so the placement of the signage would have to be contracted out. He asked if Fort Macon State Park or the Coast Guard could pay for the installation and maintenance of the markers. Capt. Popiel said he didn't think the State Park had the resources but he thought the Coast Guard could do the signage on shore. He said the Coast Guard would be willing to look at cost sharing. Chairman Harris pointed out that no wake zones ultimately cost the County money. He said the most recent one at Cannonsgate was predicated on the boating association absorbing all costs. Capt. Popiel said the Coast Guard had a navigation team that visited federally maintained floating aides on a regular basis and repaired discrepancies. He reiterated that he would be glad to explore cost sharing.

Commissioner Lewis said this wasn't an area of his expertise and he didn't feel he had enough information on the matter; therefore, he would like to table this request until he could spend some time gathering some more information. He poinfed out that this was a matter of public safety and he felt the Board should lake the time to educate themselves to make sure they made the right decision.

Motion-Commissioner Lewis moved to table this request. Commissioner Robinson seconded.
Commissioner Faircloth asked if the County had the ability to remove a no wake zone. Capt. Popiel wasn't sure but said he felt which ever jurisdiction established the no wake zone should certainly have the authority to remove it. He suggested that the County contact the NC Wildife Commission for that information.

Commissioner Hunt said he would like a better map in the future, particularly one that showed the proximity to Fort Macon.

Chairman Harris asked Capt. Popiel to find out about the Coast Guard's funding abilifies and to provide that information to Ms. Deese.

Commissioner Robinson pointed out that a CAMA permit would be required. He also noted that buoys would be less expensive.

There being no further discussion, Chairman Harris called for a vote on the motion.
Notion carried unanimously.

## RESOLUTION BY THE NORTH CAROLINA DIVISION OF PARKS AND RECREATION REQUESTING "NO WAKE ZONE" ESTABLISHMENT AT FISHING CREEK, BOGUE SOUND

WHERAS, under authority of North Carolina General Statutes, Section 75A-15(A), any provisions of the State of North Carolina may at any time, after public notice, make formal application to the Wildlife Resources Commission for special rules and regulations with reference to safe and reasonable operation of vessels on any water within its territorial limits; and

WHEREAS, upon a request by U.S. Coast Guard Sector North Carolina with full concurrence from the North Carolina State Park at Fort Macon, Carteret County has given public notice and conducted a public hearing on November 15, 2010, regarding its intention to make formal application to the Wildlife Resources Commission for special rules and regulations with reference to safe and reasonable operation of vessels on the waters of Fishing Creek, Bogue Sound, which is located within the territorial limits of Carteret County, and for the implementation of the Uniform Waterway Marker System in all of the waters of the County; and

WHEREAS, due to the fact that this no wake zone will be located within the jurisdictional waters of the State of North Carolina and the U.S. Coast Guard and will primarily serve to support Recreational Boating Safety, the U.S. Coast Guard agrees to bear all costs associated with materials and installation of signage, and the North Carolina Division of Parks and Recreation has agreed to bear all future costs associated with the establishment of this no wake zone, with regard to public notice advertisements, CAMA permits, signage and all future maintenance of signage, as required by the NC Wildlife Resources Commission.

NOWTHEREFORE BE IT RESOLVED, that in accordance with G.S. 75A-15, the North Carolina Division of Parks and Recreation requests the North Carolina Resources Commission to promulgate special rules and regulations with reference to safe and reasonable operation of vessels on the waters of Fishing Creek, Bogue Sound, located in said County, the pertinent substance of which proposed regulations is as follows: from position N34-42.270, W 076-42.417 to position N 34-42.280, W 076-41.377, as noted on the map included.

BE IT FURTHER RESOLVED, that the Carteret County Board of Commissioners requests that said Commission promulgate regulations fully implementing the Uniform Waterway Marker System in the above described channel.

# No Wake Zone Request - High Rock Lake, Davidson County Proposed Amendment to 15A NCAC 10F . 0324 

At the request of the Camp Walter Johnson Salvation Army Camp, the Board of Commissioners of Davidson County made an application to the North Carolina Wildlife Resources Commission for the creation of a no wake zone near the camp docks, located in Flat Swamp Creek on High Rock Lake. The County advertised and held a public hearing prior to submitting a certified resolution in accordance with the provisions of the North Carolina Administrative Procedure Act. Camp Walter Johnson has agreed to purchase, place and maintain the no wake buoys required to mark the zone at no expense to state or local government; therefore, submission of a fiscal note is not required pursuant to NCGS 150B-21.4.

Staff investigated the area and recommended consideration for rulemaking to mitigate water safety hazards for the campers who use the waters in the narrow area of the creek.

Notice of Text for the amendment to 15A NCAC 10F . 0324 was published in the August 1, 2011 North Carolina Register:

15A NCAC 10F . 0324 DAVIDSON COUNTY
(a) Regulated Areas. This Rule applies only to those portions of High Rock Lake, Tuckertown Lake, and Badin Lake which lie within the boundaries of Davidson County.
(b) Speed Limit. No person shall operate a vessel at greater than no-wake speed:
(3) the waters of Flat Swamp Creek on High Rock Lake beginning 50 yards north of the docks at Camp Walter Johnson and extending 100 yards south of the docks as delineated by appropriate markers.

On August 31, 2011 a public hearing was held at the Wildlife Resources Commission headquarters to receive comments on the Notice of Text. There were no attendees and no comments received. Staff recommends adoption of the amendment to 15A NCAC 10F .0324.
