Proposed Temporary Rule 15A NCAC 10D .0229 Goose Creek Game Land in Beaufort and Pamlico Counties Recommended by Agency Staff for Adoption

This rule was adopted as part of the 2022-2023 annual rulemaking cycle, was approved by the Rules Review Commission in August 2022, and received more than 10 letters of objection. A temporary rule is necessary to manage activities on Goose Creek game land in the 2022-2023 seasons. No additional changes are proposed.

1	15A NCAC 10	D .0229 GOOSE CREEK GAME LAND IN BEAUFORT AND PAMILICO COUNTIES
2	Goose Creek ga	ame land is a Seven Days per Week Area, in which the following applies:
3	<u>(1)</u>	Deer of either sex may be taken on all the open days of the applicable Deer With Visible Antlers
4		Season.
5	<u>(2)</u>	Except as provided in 15A NCAC 10D .0103 (d)(2), waterfowl in posted waterfowl impoundments
6		shall be taken only on the following days:
7		(a) the opening and closing days of the applicable waterfowl seasons;
8		(b) Thanksgiving, Christmas, New Year's, and Martin Luther King, Jr. Days; and
9		(c) Tuesdays and Saturdays of the applicable waterfowl seasons.
10	<u>(3)</u>	Beginning on the first open waterfowl season day in October through the end of all waterfowl
11		seasons, waterfowl hunting is by permit only on the following waterfowl impoundments: Pamlico
12		Point, Campbell Creek, Hunting Creek, Spring Creek, Smith Creek, and Hobucken.
13	<u>(4)</u>	On Spring Lake, Pamlico Point, and Campbell Creek Waterfowl Impoundments, all activities,
14		except waterfowl hunting on designated waterfowl hunting days and trapping during the trapping
15		season, are restricted to the posted Scouting-only Zone during the period November 1 through
16		March 15.
17	<u>(5)</u>	Camping is restricted to September 1 through the last day of February and March 31 through May
18		14 in areas both designated and posted as camping areas.
19	<u>(6)</u>	Hunting and vehicular access on the Parker Farm Tract is restricted from September 1 through
20		January 1 and April 1 through May 15 to individuals that possess a valid hunting opportunity permit.
21	<u>(7)</u>	Pursuing or chasing deer or bear with dogs for the purposes of training or hunting is prohibited on
22		the Beaufort County portion north of NC 33 except for that portion east of Smith Creek and south
23		of Campbell Creek.
24	<u>(8)</u>	Bear shall not be harvested on Sunday.

This rule was adopted as part of the 2022-2023 annual rulemaking cycle. During technical corrections, a typographical error was made removing "Tuesday" from the December Bear Season. Temporary rulemaking is required to accurately set open days of the December Bear Season on Gull Rock game land.

7		(b) Thanksgiving, Christmas, New Year's, and Martin Luther King, Jr. Days; and	
8		(c) Tuesdays and Saturdays of the applicable waterfowl season.	
9	(3)	Camping is restricted to September 1 through the last day of February and March 31 through May

11	(4)	Bear may only be taken the first Saturday, Monday, and Tuesday of the November Bear Season and	
12		the second Saturday, Monday, and <u>Tuesday</u> of the December Bear Season.
