Includes hunting for big game, hunting on game lands, hunting for waterfowl (does not include the bear management e-stamp or federal duck stamp), fishing in designated Public Mountain Trout Waters, fishing in trout waters on game lands, and fishing in joint waters. It does not include fishing in coastal waters.

²Unified Infant/Youth Sportsman/Coastal Recreational Fishing: Statewide hunting, inland and coastal recreational fishing. Includes hunting for big game, hunting on game lands, hunting for waterfowl (does not include the bear management e-stamp or federal duck stamp), fishing in designated Public Mountain Trout Waters, fishing in trout waters on game lands, and fishing in joint waters.

³Infant/Youth Coastal Recreational Fishing: Authorizes fishing in coastal and joint waters. It does not authorize fishing in inland waters.
