If the source birds are not part of NPIP, they must be tested pullorum-typhoid and avian influenza negative by NPIP standards within 30 days prior to entry into North Carolina. Health certificates for imported waterfowl shall be available for inspection by authorized Commission personnel upon request.

I hereby certify that all information contained herein is accurate and truthful to the best of my knowledge. I have read and understand the rules and statutes pertaining to the collection of wildlife in North Carolina, under 15A NCAC 10H.0100, 15A NCAC 10H .0900, and G.S. 113-272.4, and agree to abide by these regulations.
