

Nominations Sought for 2012 Wildlife Conservation Award

The N.C. Wildlife Resources Commission is seeking nominations through Jan. 30 for the seventh annual Thomas L. Quay Award.

The award recognizes individuals who make outstanding contributions to wildlife diversity in North Carolina and who are considered leaders in wildlife resources conservation.

Anyone interested in nominating someone for the award must submit the nomination form on the next page and a detailed explanation of the nominee's contributions to wildlife conservation. The explanation is limited to two pages (8 ½ x 11-inch paper, with 1-inch margins, single spaced and 12-point font.) Submissions that exceed the 2-page limit will be disqualified and returned to the nominator.

The Nongame Wildlife Advisory Committee will recommend nominees for consideration by the Wildlife Commissioners at their May meeting. The winner will be announced at the Commissioners' meeting in July.
